About KRI International Level 2 Certification

The KRI Level 2 Teacher Training is Transformational and requires completion of five modules for KRI International level 2 Certification.

KRI requires that the process takes a minimum of two years to complete.

The five modules are

1. Authentic Relationships
2. Conscious Communication
3. Mind & Meditation
4. Stress & Vitality
5. Lifecycles and Lifestyles

The modules can be taken in any order. It is recommended to leave approximately 4 – 6 months between modules to enable integration. Each Level 2 module has 48 contact hours with a certified Level 2 Trainer and approximately 12 hours of post course integration study. This includes the practice of a 90 day meditation, group conference calls, an exam and other homework assignments. A level 2 module is a 90 day commitment.

The post course work is vital to the integration of the material and the experiences offered during the course. The transformative nature of Level 2 is in the depth of experience during the course, and in integrating the professional development skills learned, living the values embodied and participating in service within our communities.

Requirements for Completion of Level 2 Authentic Relationships

- Level One Kundalini Yoga Teacher Qualification
- Attendance at all group classes and retreats
- Completion of a 90 day sadhana including keeping a journal of the experience
- Pass the examination
- Satisfactory evaluation by the faculty
- Payment in full of course fees
- Live a yogic lifestyle to the best of your ability
- At least 6 hours reading of Yogi Bhajan transcripts, watching videos and practising the meditations given in the videos.
- At least 6 hours of study group meetings or conference calls
- At least 40 days of journaling
